RULES OF HARNESS RACING REFERENCE COLOURS RULE 452 & 453 AND THE COLOURS REGULATIONS

No duplication of any colour will be registered.

- For the purpose of this Regulation, the various colours within a group shall be considered as one colour. eg Gold grouped with yellow, tangerine & orange. Red grouped with maroon & scarlet etc
- Where the following designs or patterns are used they must comply with the specifications set out below.
- Other designs, patterns, logos or arrangements must be submitted to the Board for approval and may be registered if the colours applied for would be clearly distinguishable, and sufficiently different from other registered colours and would not cause offence.
- Registration of all colours shall be renewed in the month of August 1995, and in the same month in every succeeding third
 year thereafter.

OWNERS COLOURS - Please note:

Rule 452(2) - A horse shall race in the registered colours of, an owner, the joint owners or syndicate, or the trainer of the horse.

Explanation

- Colours registered in one name only may be used in connection with the racing of any horse in which that person owns a
 registered share.
- Any two or more persons may register joint colours & any Syndicate may register colours.
- Colours registered jointly can be used on all horses owned jointly as well as any horses owned individually provided all owners are
 in agreeance.

SIZE SPECIFICATIONS

- Stars shall not be less than 114mm from point to point
- Spots shall not be less than 89mm in diameter
- Diamonds shall not be less than 127mm x 89mm
- Chequers shall not be less than 76mm x 76mm
- Sashes & Crossed Sashes shall not be less than 89mm wide
- Braces shall not be less than 89mm wide
- Stripes & Diagonal Stripes shall not be less than 76mm wide
- Hoops shall not be less than 89mm wide
- Seams shall not be less than 20mm wide
- Armbands shall not be less than 89mm or more than 102mm wide, one to each sleeve and placed above the elbow.

Also available: Halves, Quarters, Yokes, 'V's, Horseshoes, Maltese Cross and Cuffs

• Short Sleeved Colours approved 21/02/08

Short-sleeved colours are permitted provided that the registered sleeve pattern and description is maintained.
