EXPLANATION: This form should be completed in all cases where a horse is competing in a Monté Racing event. The completion of this form does not replace gear that is nominated for when the horse is racing in trotting races with a sulky. This form is only used to nominate gear being used in Monté racing that is different to any gear previously notified. In all instances, a crupper, saddle and breast plate must be used. Reins are to be held in two hands with the exception of activating gear and cannot be attached using a carbineer or snap hook.

Any change after this time will only be permitted with the permission of the Stipendiary Stewards.

Please refer to Rule 865 and the Approved Gear Regulation. In the case of two day meetings all gear changes for the second day must be lodged with the Stipendiary Stewards at the meeting. Gear changes will be accepted when notified on an Official form only.
