Race 2 UP TO & INCLUDING R50 MOBILE TROT 2200m (Tentative)
Of \$15000

For up to & including R50 trotters. Preferential Barrier Draw Based on: Rating then Winning Stakes using the track grid. Selection preference to those horses not guaranteed a start in the Provincial Trotters Final.

Race 3 R35 & FASTER DISCRETIONARY HANDICAP TROT 2200m (Tentative)
Of \$35000

For R35 & faster trotters. Should a horse win both a heat and the final the win in the final will be penalty free. Eligible to nominate, horses who ran in the heats run on 3rd & 17th January. First 3 placed runners from the heats run on the 3rd & 17th January are guaranteed a start in the \$35,000 Final to be run on Fri 24 Jan should they be nominated. Balance of the field if required to be determined by the club. Should a horse win both a heat and the final the win in the final will be penalty free. A horse must run in a heat in order to be eligible for the final.

Race 4 R50 & FASTER DISCRETIONARY HANDICAP TROT 2200m (Tentative)
Of \$25000

For R50 & faster trotters. Please Note: This race has a maximum back mark of 30m.

Race 5 NON-WINNERS FILLIES & MARES MOBILE PACE 1700m (Tentative)
Of \$15000

For pacing fillies & mares.

Race 6 NON-WINNERS MOBILE PACE 2200m (Tentative)
Of \$15000

Race 7, 8 UP TO & INCLUDING R50 MOBILE PACE 2200m (Tentative)

First 3 placed runners from the heats are guaranteed a start in the \$35,000 Final to be run on Fri 24 Jan should they be nominated. Balance of the field should this be required to be determined by the club. Should a horse win both a heat and the final the win in the final will be penalty free. Heats and final limited to 12 starters. A horse must run in a heat in order to be eligible for the final.

Race 10 R50 & FASTER DISCRETIONARY HANDICAP PACE 2200m (Tentative)
Of \$15000

For R50 & faster pacers. The winner will get a rating penalty free win if 4YO and older, and driven by a Junior Driver, and has not previously won a rating penalty free race this season. Please Note: This race has a maximum back mark of 30m.
