Race 1 NON-WINNERS WITH COND. SPECIAL HANDICAP TROT 2100m (Tentative)
Of \$11500

Front: Trotters with no wins for lifetime. 30m: Horses with 1 win for lifetime. If insufficient nominations the lowest rating and or conditioned horses from Race 2 may be included in the field.

Race 2 R35 & FASTER DISCRETIONARY HANDICAP TROT 2100m (Tentative)
Of \$20000

For R35 & faster trotters. The winner will get a rating penalty free win if 4YO and older, and driven by a Junior Driver, and has not previously won a rating penalty free race this season. A Northern Regional Trotters Cup Qualifier. If sufficient nominations two races may be run. The lower rating race for a stake of \$11,500.

Race 3, 4 NON-WINNERS MOBILE PACE 2000m (Tentative)
Of \$11500

Races 3 & 4 to be split as determined by the club based on the nominations received.

Race 5 4YO & OLDER R35 TO R50 MOBILE PACE JUN.DRV 2000m (Tentative)
Of \$11500

For R35 to R50 4yo-&-older pacers. This race is for Junior Drivers only and has a Preferential Barrier Draw Based on: Winning Stakes using the track grid. Rating Penalty Free Race. Refer Revell Douglas Memorial Series Conditions on the HRNZ Website/Race Schedules & Conditions. Please Note: The winning horse from the Heat 1 run on 27 Jan & Heat 2 run on 31 Jan 2025 is ineligible for this race.

Race 6, 7,8 R35 TO R54, WITH COND. MOBILE PACE 2000m (Tentative)
Of \$12500

For R35 to R54 pacers. Also horses with up to 2 wins for lifetime. The highest rating race to be run as the Taranaki Mobile Pacers Cup for a stake of \$12,500. The lower rating races to be run for a stake of \$11,500. Preferential barrier draws may apply should it be deemed necessary to ensure overall fairness to all horses given the ratings spread in these races. Ratings and or conditions may be used by the club when determining the splits for these races.

Race 9 R50 & FASTER DISCRETIONARY HANDICAP PACE 2100m (Tentative)
Of \$20000

For R50 & faster pacers. The winner will get a rating penalty free win if 4YO and older, and driven by a Junior Driver, and has not previously won a rating penalty free race this season.

Special Conditions**1. RATINGS PROGRAMME**

This programme is ratings based. It is a likely indication of the programme that will be in place for the meeting. Where it is required changes will be made to the final programme after the close of withdrawals. Ratings bands and other conditions shown only serve as an indication as to how races will likely be programmed. As nominations permit race conditions will be programmed to ensure horses can race in a competitive environment whilst also optimizing field sizes and where possible ensuring as many horses as possible gain a start. Some minimal movement of horses may be required when finalizing fields to accommodate trainer splits.

2. ONE NOMINATION PER HORSE

Trainers are advised that a horse may only be nominated for One Race at this meeting. Trainers do however have the right to Transfer their horse(s) following the close of Nominations. The Club reserves the right to transfer any horse deemed necessary, unless trainers specify that their horse(s) is NOT to be Transferred.
