Race 1 WITH COND. TROT 2600m (Tentative)
Of \$20000

For 3 yrs & older trotters with up to 1 win for lifetime. Full conditions of this series can be viewed online in the Racing Schedules & Conditions section of the HRNZ website. Any eligible trotter with 2 or more lifetime wins will start of a 20m handicap.

Race 2 3YO & OLDER R35 TO R40 TROT 2000m (Tentative)
Of \$11000

For R35 to R40 3yo-&-older trotters.

Race 3 3YO & OLDER R41 TO R50 TROT 2000m (Tentative)
Of \$11000

For R41 to R50 3yo-&-older trotters.

Race 4 WITH COND. MOBILE PACE 2000m (Tentative)
Of \$20000

For 3 yrs & older pacers with up to 1 win for lifetime. Full conditions of this series can be viewed online in the Racing Schedules & Conditions section of the HRNZ website. Any eligible pacer with 2 or more lifetime wins will start from the Least Preferential Barrier Draw.

Race 5 NON-WINNERS 3YO & OLDER MOBILE PACE 2000m (Tentative)
Of \$11000

For 3yo-&-older pacers. This race is only for non-win horses that have not qualified for or are ineligible for the Anne Thompson Pacing Graduation Series Final. Also eligible are any horses selected as emergencies for the Final.

Race 6 5YO & OLDER R35 MOBILE PACE 2600m (Tentative)
Of \$12500

For R35 5yo-&-older pacers. Canterbury Plains Challenge Consolation.

Race 7, 8 3YO & OLDER R35 TO R45 MOBILE PACE 2000m (Tentative)
Of \$11000

For R35 to R45 3yo-&-older pacers.

Race 9 4YO & OLDER R35 TO R45 SPECIAL HANDICAP PACE 2600m (Tentative)
Of \$12000

For R35 to R45 4yo-&-older pacers. Front: R35 to R40. 15m: R41 to R45.

Race 10 4YO & OLDER R45 TO R60 SPECIAL HANDICAP PACE 2600m (Tentative)
Of \$15000

For R45 to R60 4yo-&-older pacers. Front: R45 to R50. 10m: R51 to R55. 20m: R56 to R60.

Special Conditions

1. ONE HORSE ONE NOMINATION

A horse may only nominate for one race on the programme/race day, the trainer has the right to transfer the horse if he/she wishes, and may advise the club at the time of nomination whether the horse is to be transferred or not.

2. DUAL ACCEPTORS

Selection Preference for this meeting, in the first instance, will be given to horses that are not already accepted into a race(s) at another meeting. This condition includes races later than this race day/night. This condition will not apply to races that are covered by specific series or race conditions; e.g. NZ Sires Stakes Board Administered races.

3. LATE NOMINATIONS

In the event Nominations are extended for any races or the meeting, selection preference will be given to those horses that Nominated at the original closing time. Except in the case of Non-Win races, where Field Selection Regulations take precedence or where specific race or series conditions are Programmed. No late Nominations will be permitted to transfer from the race that they have nominated for, unless the club requires it.

4. ELIGIBILITY

Any horse is eligible to nominate & accept for a race that has a higher Rating than it has. However, preference will be given in the first instance to horses that the race caters for in terms of Rating. Races Programmed with an 'R' rating will see preference given to 'R' rated horses over 'MR' rated horses.

5. FIELD SELECTION

Field Selection for this meeting will be conducted in line with the Handicapping Regulations for non-win or non-win front races. That being; first and second preference horses will be selected in the first instances and thereafter at clubs discretion. All other races will be selected at the clubs discretion or per the conditions attached to each Programmed race.

6. SPLIT FIELD NOMINATIONS

Should any race on this programme be able to be split it will be done so on the basis of highest to lowest rating or vice versa, by sex or by a yet to be decided method, as the Club sees fit. This does not apply where conditions are detailed in the race programme. Owner, Trainer & Driver splits will not be taken into consideration if the race is split.

7. HEALTH & SAFETY NOTICE
