**Race 1 2YO MOBILE TROT 1700m (Tentative)**  
Of \$15000

For 2-year-old trotters. Preferential Barrier Draw Based on: Winning Stakes using the track grid.

**Race 2 NON-WINNERS 3YO & OLDER TROT 2200m (Tentative)**  
Of \$15000

For 3yo-&-older trotters.

**Race 3, 4 R35 & FASTER DISCRETIONARY HANDICAP TROT 2700m (Tentative)**  
Of \$20000

For R35 & faster trotters. The winners will get a rating penalty free win if 4YO and older, and driven by a Junior Driver, and has not previously won a rating penalty free race this season. Ratings and or conditions may be used by the club when determining the splits for these races. The lower rating of these two races to be run for a stake of \$17,000.

**Race 5 NON-WINNERS MOBILE PACE 2200m (Tentative)**  
Of \$15000

**Race 6 2YO FILLIES MOBILE PACE 1700m (Tentative)**  
Of \$30000

For 2-year-old pacing fillies. Refer NZ Sires Stakes for full series conditions.

**Race 7 4YO & OLDER R35 TO R45 MOBILE PACE 1700m (Tentative)**  
Of \$12500

For R35 to R45 4yo-&-older pacers. Rating Penalty Free Race. For 4yo & older pacers who have had two or more totalisator starts in the North Island, outside of Alexandra Park since 1 June 2024. Field to be selected with preference to those with the most starts in the North Island outside of Alexandra Park during this period. Ineligible: The winner of the South of the Bombay's conditioned pace run on 9 August 2024.

**Race 8, 9 3YO+ UP TO & INCLUDING R55, WITH COND. MOB. PACE 2200m (Tentative)**  
Of \$17000

For up to & including R55 3yo-&-older pacers. Also horses with up to 2 wins for lifetime. Preferential Barrier Draw Based on: Rating using the track grid. These heats to be selected from the highest rating downwards and will be limited to 12 runners per heat. First 3 placed runners from each heat are automatic qualifiers for the \$35,000 Final to be run Friday 6 September 2024. Automatic qualifiers will not be eligible to nominate for any race other than the Final on the race-night of 6 September 2024. Refer full series conditions. Should a horse win both a heat, and subsequently the final on Friday 6 September the win in the final will be penalty free.

**Race 10 UP TO & INCLUDING R70 MOBILE PACE 1609m (Tentative)**  
Of \$17000

For up to & including R70 pacers. Preferential Barrier Draw Based on: Rating using the track grid. Field to be selected from the highest rating downwards.
