1. THE Lessee shall do all that is reasonably necessary to keep the horse in sound health and condition.
2. THE Lessee shall not without the previous written consent of the Lessor assign his right or interest in the said horse under this agreement or under-lease him or part with the possession of the said horse.
3. THE Lessee may terminate this agreement at any time by handing over the said horse to the Lessor after having given the Lessor at least one week's notice in writing of the Lessee's intention to so terminate this agreement and notice thereof shall forthwith be given by both parties to the Chief Executive of Harness Racing New Zealand pursuant to the provisions of Rule 428.
4. IF the Lessee shall become bankrupt or if judgement shall be entered or execution issued against him or his estate or if he shall make default in observing or performing any of the agreements on his part herein contained the Lessor his servants or agents may retake possession of the said horse and thereby determine the estate of the Lessee therein but with out releasing him from liability in respect of rent accrued due or for damages for the breach or non-observance of such agreement up to the time of such retaking of possession and notice therefore shall forthwith be given by both parties to the Chief Executive of Harness Racing New Zealand pursuant to the provision of Rule 428.
