Nomination Categories (as per Clause 6.0)

(A) Stallions Resident / Standing in New Zealand – (6.2)

Resident NZ Shuttle

Progeny will be eligible –

Validate NZ Services Only

Where a service certificate has been lodged with HRNZ.

Where semen has been exported from NZ. In this case the foal nominator will be required to pay a premium fee of NZ\$200.00 incl. GST in addition to the normal foal nomination fee.

Where semen is exported the overseas services will not be included when calculating the second stallion instalment.

Validate NZ & Australian Services

The Stallion Nominator can choose to eliminate the need for foal nominators to pay the premium as above for foals resulting from semen exported to Australia by validating all Australian services and this will be included when calculating their second stallion instalment

Closing date: 1st September 2017

(B) Import Semen into NZ (Chilled/Frozen) (6.1.2)

Validate NZ Services Only

Validate only the New Zealand services in which case the second stallion instalment will be calculated on those services only and only the progeny from these services will then be eligible.

Where the Australian services of a nominated stallion have not been validated a sire validation fee can be paid at foal time. (9.3.4)

Validate NZ & Australian Services

Validate the services for both New Zealand and Australia – in which case the second stallion instalment will be calculated on the number of service certificates registered in both countries and the stallion nominator will be liable for this payment. Where Australian services are to be validated, the rebate on the second stallion instalment for serving less than 50 mares in total will not be applicable. (see Clause 5.2.1)

Any foal that does not have a NZ brand and is by non-nominated stallion will be ineligible.

Closing Date – 1st September 2017

(C) Retiring from the Race Track after the Closing Date (6.1.3)

Stallions retiring from racing may be nominated providing the appropriate fee is paid within 7 days of any stallion being registered for breeding purposes and before any mare is served.

Closing Date – 1st September 2017 if retired after that - Prior to any mare being served – see conditions

Nomination Fee: (4.0)

1st Instalment:-

A sum equivalent to 25% of the advertised service fee (excludes working fee) at which the stallion will stand for the 2017/2018 season plus GST.

(Minimum Fee for calculation purposes - \$1000-00 plus GST)

2nd Instalment:-

As prescribed in the Conditions payable on or before 31st May 2018.
